

## **Spouse contributions**

When you're in a relationship, managing life and saving for goals is usually a joint effort. If you're ready to look at smart ways to manage your super as a couple, we're here to help. Your spouse is able to make contributions into your HESTA for Mercy account to help boost your retirement outcomes and, depending on your circumstances, they may be eligible for a tax offset bonus.

### Spouse contributions eligibility

To share your combined wealth and help top up your retirement savings, your spouse can make after-tax contributions into your HESTA for Mercy account.

We can accept spouse contributions where:

- you and your spouse must be under 75 years of age
- you must both be Australian residents for tax purposes
- you must be married or in a de facto relationship
- you have given us your TFN.

Spouse means:

- another person to whom you are legally married, or
- another person, whether of the same or different sex, with whom you are in a relationship that is registered under a law of a State or Territory, or
- a person who, although not legally married to you, lives with you on a genuine domestic basis in a relationship as a couple.

### Getting your super sorted

### Tax offset

A maximum tax offset of \$540 may be available for up to \$3,000 of superannuation contributions made by a contributing spouse on behalf of a non-working or low-income spouse.

**HEST** 

Let's look at the rules:

- your spouse's total assessable income must be \$37,000 or less for you to qualify for the full tax offset and less than \$40,000 for you to receive a partial tax offset
- your spouse has not exceeded their non-concessional contribution caps for the current financial year, and
- your spouse's super balance was not more than the transfer balance cap on 30 June of the previous financial year.

### **Payment options**

There are two ways you can make spouse contributions:

#### 1. BPAY<sup>®</sup>
